As part of its Energy Efficiency Plan, Énergir offers its customers grants to help them reduce their consumption of natural gas.

This document is addressed to current, or about to become¹, Énergir Business Market customers, whose annual consumption of natural gas is below 150,000 m³ and who wish to carry out renovation work aimed at replacing windows and/or improving the insulation of roofs and/or walls.

This document explains the conditions of the Energy Efficient Renovation Grant and assists customers in declaring their intention to participate to Énergir.

Conditions

Eligibility criteria

- Use natural gas as the principal source of energy for space heating the building covered by the project.
- Be an Énergir customer or about to become one¹ who consumes less than 150,000 m³ of natural gas per year.²
- Operate in one of the following activity sectors:
 - Commercial sector;
 - Multi-tenant buildings with four or more units;
 - Institutional sector;
 - Industrial sector.
- Exceed the minimum requirements³ in your renovation project.
- Submit your request to participate to Énergir before carrying out the renovation project by completing the Declaration of Intent form (page 3). Énergir considers that the start of work corresponds to the date of signing the first contract for carrying out the renovation project.

Calculation of amount of grant

- \$30 per square metre of eligible windows replaced up to a maximum of 7.5% of the cost of purchase and installation of the new windows.
- \$8 per square metre of eligible walls or roofs renovated up to a maximum of 75% of the cost of purchase and installation.

The total amount of the grant may not exceed **\$40,000** per fiscal year per Énergir account number (a project may include more than one type of measure). Requests for less than \$500 are not eligible.

Contribution from other organizations

Any customer participating in or covered by another financial assistance program for realizing this project agrees to declare to Énergir all amounts received or expected to be received from other energy distributors or government organizations for this same project. Énergir will pay the customer the financial assistance envisaged under this Program, minus the contributions from other organizations for this same project, so that the portion payable by the customer represents at least 25% of the costs related to this project.

Steps to follow

Step 1

Customer sends Declaration of Intent to Énergir (Form I).

Step 2

Energir acknowledges receipt of Declaration of Intent to customer by e-mail. Effective from the date the acknowledgement of receipt is sent, the customer has one year to carry out the renovation work and submit the end of work documents to Énergir (Form II and supporting documents).¹

Step 3

Customer carries out the renovation work.

Step 4

Customer submits Form II (After the work) duly completed and accompanied by the following documents:

- photos taken before the work (insulation work only);
- photos taken after the work;
- copy of submission from contractor;
- copy of bills for renovation work;
- technical data sheets for windows and insulation materials, if available;
- all other documents required by Énergir for analysis purposes.

Step 5

Énergir analyzes the file and requests modifications, if necessary. Énergir confirms its acceptance or refusal of the financial assistance in writing, indicating amount of grant awarded.

Step 6

Customer sends Énergir <u>a bill</u> claiming the amount of the grant, including applicable taxes.

Step 7

Once the file is considered complete and in compliance with the terms and conditions of this Program, Énergir will inform the customer accordingly and issue a cheque.

Step 8

Energir reserves the right to carry out an unscheduled inspection visit to the project site in the 24 months following completion of the project. If this inspection reveals that the declared renovation work has not been implemented, the customer agrees to immediately pay back the amount of the grant to Énergir.

Beyond this date, Énergir reserves the right to refuse eligibility for the financial assistance.
