By applying this policy rigorously, Énergir ensures that its investments of funds and efforts effectively enhance community well-being and create meaningful impact in the areas it prioritizes.

#### Our guiding principles

### Commitment to the communities we serve

Énergir's philanthropic efforts are rooted in local engagement, aiming to make a meaningful impact in the communities we serve across Québec.



#### Donations to support missions rather than philanthropic events and sponsorships

To maximize its impact, Énergir prioritizes donations that align with the missions of organizations operating within its key areas of focus. As a result, the purchase of benefit event tickets and philanthropic sponsorships are not encouraged.

## A collaborative approach, to address issues systemically

To address the needs and complex challenges within its focus areas, Énergir actively promotes collaborative initiatives between organizations and other stakeholders.



# Initiatives with collaborative opportunities for our employees

Énergir invests—and is deeply invested—in other ways: initiatives that foster collaboration and engagement with our employees are highly valued and encouraged.


#### Our areas of action


Énergir is committed to addressing urgent needs today while investing in a better tomorrow. We achieve this by focusing on three key areas where we aim to make the greatest impact.








Supporting vulnerable youth

Supporting climate change adaptation

Aligned with its commitment to driving the energy transition, Énergir supports initiatives that foster adaptation to climate change.

- Projects contributing to GHG reduction

While the needs are real, the solutions are many: organizations<sup>3</sup> have full discretion to demonstrate how they are addressing one or more of these areas through their mission, initiatives or projects.

#### Eligibility criteria

To be eligible for evaluation, an application must meet the following criteria:

- Be submitted via the online form.
- Come from a non-profit organization recognized as a registered charity by the Canada Revenue Agency, and operating in Québec.
- Align with one of Énergir's prioritized areas of action.
- Be supported by a thorough and comprehensive file that demonstrates the impact of the mission or project and its link to the areas of action prioritized by Énergir.
- Be submitted to Énergir 8 to 12 weeks prior to the expected response date.

#### **Exclusions**

Énergir does not contribute to causes, projects or organizations:

- That have already received financial support from Énergir within the same year.
- Whose mission is linked to a religious, advocacy or political group.
- Whose plan is related to the construction, renovation, restoration or acquisition of premises or buildings.
- Whose application is for reimbursement of natural gas consumption costs.
- Whose application is from student associations or for school or university competitions.

#### Obligations of organizations

- Upon request, organizations must provide a report detailing the administration of the donation and the project's impact on the target audience within six months of project completion or within one year of the disbursement. For annual donations exceeding \$25,000, organizations must submit an annual report in a format of their choice.
- All renewal requests are subject to a new analysis, as no agreements are automatically renewed.
- For each donation of \$25 or more, organizations must issue a tax receipt to Énergir. For tax purposes, particularly for fundraising events, organizations must specify the portion of ticket costs that constitutes a direct donation to the organization or its cause.
- Organizations authorize Énergir to use their name in communications to highlight Énergir's community contributions.

All applications must be submitted through the online form available on Énergir's website. Please allow 8 to 12 weeks for the review and analysis process.
